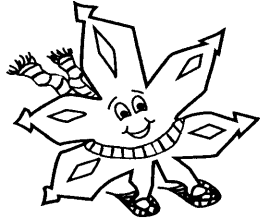

Registration: 8:00 – 9:30 A.M. **Race Start:** 10:00 A.M. (5k & 10k Race)

Entry Fees: \$20.00 Pre-register (postmarked by 1/18/12);
\$25.00 After 1/18/12, including Race Day;
\$ 4.00 Children 9 & under (Only participation medal)

Awards: In both the 5k & 10k, custom trophies to the overall male & female finishers and medals to the top three in the following age groups: 10-14; 15-19; 20-29; 30-39; 40-49; 50-59; 60-69; 70+. Children 9 and under will receive a participation medal!

Course: Both courses consist of groomed ski trails & packed single track and feature rolling terrain and a few large hills that traverse over the beautiful school forest.

Perks: Long sleeve t-shirts guaranteed for those who pre-register. Extra shirts will be available on a first come-first serve basis. Door prizes from our product sponsors, including skis & snowshoes, will be drawn for those in attendance at awards ceremony. Refreshments will be available for purchase, including chili, hot chocolate and baked goods.

Location: All race activities will be held at the Phillips School Forest. From Hwy 13, go East on County Hwy H for 3 ½ miles; turn South on Big Elk Road for ½ mile; when the road splits, stay right on Worcester Road and follow the signs to the entrance.

NEW! Team Division: Four divisions include Mens, Womens, Mixed & Corporate. Each team needs a minimum of 4 members (no maximum). Overall awards to the top team in each division, as well as to the team with the highest number of finishers. 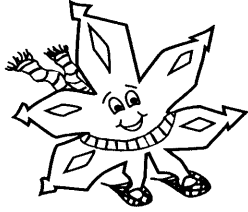
